

What's that Pool?

The **Zero-Depth Pool**, also known as the Beach Pool, gradually goes from 0 - 3.6 feet. In the shallow end are fountains and a toddler turtle slide.

The **West Pool** is a large recreational pool with plenty of swimming room with the depth ranging from 3 – 5 feet. Connected to this pool is a diving well that is 10 feet deep with a low and high diving board.

The **Waterslide** is 160 feet long with a splashdown pool that is 3.6 feet deep. This pool is not for swimming, only for going down the waterslide.

The sand play area with **beach volleyball court** is available for use at all parties. We encourage you to bring your own ball.

***Swimsuits with liners** are required for everyone entering the pools. This is a state law.

Frequently Asked Questions

Q: *What if it rains the day of our party?*

A: The PFAC will do its best to reschedule for a different date if that is your wish; however, it is not guaranteed! It is suggested to have your party unless the weather is extremely horrible or dangerous.

Q: *Is alcohol allowed at our party?*

A: Only if the PFAC has approved this and has a copy of the homeowner's insurance on file in advance. The alcohol **must** be brought in containers that are **NOT** glass!

Q: *Can we use the concession stand during our party?*

A: The concession stand can be requested to be open in advance, and staff will be scheduled for the event (increasing the cost of the party due to staff fees).

Please read carefully before signing the form.

Payment: Total payment is due at least one week in advance of the date of the facility rental. Confirmation of reservation will not be made official until fees are received. There will be no refund of the deposit or any part of the payment if the party is cancelled.

Policies: For all group activities, the Village requires lifeguard(s) and staff person(s) to be assigned for the duration of the event at the applicant group's expense. The Village reserves the right to assess the proper number of staff per party rental.

All details for activity arrangements shall be made between the activity sponsors and the Facility Rental Contact or Manager.

Organizations may not deface any portion of the building for decorations, etc., in furtherance of their activity. All decorations must be approved by the Manager well in advance of the scheduled activity.

No admission fee is to be charged at the door or **tickets sold** for the purpose of having an event at the Aqua Center.

Alcoholic beverages will only be allowed by special permit with the group providing the necessary insurance coverage. **NO GLASS ITEMS ARE ALLOWED ON THE PREMISES!**

The facility should be left in a satisfactory condition. The requesting organization, upon submitting this application agrees to pay the cost of necessary repairs or replacement of pool equipment lost or damaged as a result of their activity.

All Recreation Department and Aqua Center Rules and Policies shall be observed by all groups and shall be enforced at the discretion of the Aqua Center Staff.

All activities shall be under control and shall be operated and supervised to the satisfaction of the Department. **If the activity is unsatisfactorily operated or supervised, it will result in loss of consideration of future requests from the organization and/or cancellation of the activity at that time.**

We have read this form and will conform to the regulations set forth. The Undersigned program sponsors further agree to hold the Village of Park Forest harmless and Indemnified and to protect said Village from any claims for damages or expenses of defending any such claims for damages of any nature resulting from the use of said premises by the Undersigned, its agents, representatives, invitees, or any other person, including, but not limited to the repair of any damages to any Village property of any nature resulting from such use by the Undersigned, their representatives, invitees, or any other person, are liable for any negligence or negligent action on their part during the use of above said premises. We have the right to cancel the party for any reason. **Applications must be signed by an adult (21 years or older) who will assume any and all responsibility.**
