34-27 APPLICATION FOR ANNUAL ALARM SYSTEMS AUTHORIZATION.

(B) Every alarm user authorized under this chapter shall be required to have his/her alarm system inspected and tested at least once a year. This inspection can be conducted by the homeowner / resident / business alarm user or licensed alarm contractor.

34-33 PENALTY.

Any person violating any of the provisions of this chapter shall, on conviction thereof, be subject to a fine of not more than \$750 for each offense.
